### CANDIDATE ELIGIBILITY REQUIREMENTS & DEADLINE TO FILE

CANDIDATE ELIGIBILITY REQUIREMENTS	DEADLINE TO FILE CANDIDATE APPLICATION**
<ol style="list-style-type: none"> <li>1. Must be a United States Citizen</li> <li>2. Must be a registered voter on the date of the election</li> <li>3. Must be a resident of the City of Balch Springs for one (1) year prior to the date of the election.</li> <li>4. A candidate for City Council must meet the requirements as provide by the Texas Constitution, Texas Election Code and other laws of the State of Texas.</li> <li>5. The City Secretary shall be responsible for having a background check conducted for each candidate who files for office to determine whether any has been convicted of a felony, and in the event that it is determined that any candidate has been convicted and has not been pardoned or otherwise released from the resulting disabilities, the City Secretary shall notify that person in writing that he or she is not qualified to be a candidate to hold office.</li> </ol>	<p>February 18, 2022 by 5:00PM</p>

*\*\*The filing period begins on the 108<sup>th</sup> day prior to the election date and ends on the 78<sup>th</sup> day at 5 p.m. prior to the election date.*
